PERSONAL DATA

Your personal data is in principle only used by Oriental Merchant (Europe).

Oriental Merchant (Europe) takes security measures to prevent misuse or unlawful access to personal data. The following specific measures are taken: access to personal data requires input of a user name and password.

We do not provide your personal data to third parties without your permission, unless we are required to do so by law or court order or if this is required for the execution of an agreement between you and Oriental Merchant (Europe).

You have the option to view, change or delete your personal data at any time. In that case, please contact us.

LEGAL GROUNDS

We base the processing of personal data on various legal grounds. We process a large part of your personal data because it is necessary in order to fulfill our agreement with you (article 6 sub b AVG). In addition, we process your personal data because it is necessary for us to represent our legitimate interest to keep you informed and to keep track of our activities and/or to deliver our newsletter (article 6 sub f AVG). Finally, in certain situations we are obliged to process your Citizen Service Number and a copy of your ID document, for example if we employ you.

STORAGE PERIOD

Oriental Merchant (Europe) does not store your personal data any longer than the period required for achieving the purpose for which it was collected and processed.

COOKIES

Our site uses cookies. A cookie is a small file that is sent along with pages of the site and stored locally on the hard disk of your computer. On this website we use Google Analytics (part of the American company Google) to analyse anonymous visitor data and improve our website. Google may be required to provide this information to third parties. Most browsers accept standard cookies, but usually this can also be turned off. However, it may result in a website no longer functioning correctly or fully. We therefore recommend that you regularly delete your cookies instead.
